

LAST WILL
OF
ORSON WELLES

I, ORSON WELLES, a resident of the state of Nevada, hereby make and declare this to be my Last Will and revoke all other Wills and Codicils previously made by me.

FIRST: I declare that I am presently married and that my wife's name is PAOLA WELLES and that any references in this Will to my wife are to her. I declare that I was previously married which marriages ended in divorce. I further declare that I have three adult daughters (each by a previous wife) whose names are: CHRISTOPHER WELLES FEDER, [REDACTED], [REDACTED], New York, New York 10003, BEATRICE WELLES, Scottsdale, Arizona and REBECCA WELLES, [REDACTED], [REDACTED], Tacoma, Washington 98405. Any references to my children or their issue shall only include my three daughters referred to above.

SECOND: I intend by this Will to dispose of all property that I may dispose of by Will, including any and all separate property and all of my interest in any property deemed to be community property of my wife and myself.

THIRD: Except as set forth in Article FIFTH of this Will, I give to my wife, if she survives me, all of my jewelry, clothing and other items of personal adornment, personal automobiles, silver, books, pictures, paintings, works of art and other personal effects. If my wife does not survive me, the bequest made in this article shall lapse. The beneficiary of any gift under this Article THIRD shall have free use thereof during the administration of my Estate.

FOURTH: I hereby make the following specific gifts:

A. I give to each of my daughters or their Estate if they predecease me, \$10,000.00.

B. I hereby give to Olga Palinkas (also known as Oja Kodar), whose address is [REDACTED], Republic of Yugoslavia, the house located at 1717 North Stanley Avenue, Los Angeles, California, subject to the promissory note secured by a trust deed on such property, and all of the improvements and household furniture, furnishings, pictures, books, silver, paintings, works of art and other personal effects therein. In the event Olga Palinkas predeceases me then this gift shall lapse and become part of the residue of my Estate. All taxes attributable to this bequest shall be paid from the residue of my Estate.

FIFTH: I give, devise and bequeath all of the rest, residue and remainder of my Estate to my wife, if she survives me. In the event she does not survive me, then all such property shall go to Olga Palinkas if she survives me. In the event neither my wife nor Olga Palinkas survives me, then all of such rest, residue and remainder of my Estate shall be distributed to my heirs-at-law under the then law of California. In the event that there are no heirs surviving such event, then all of the rest, residue and remainder of my Estate shall be distributed to the Motion Picture and Television Home in Woodland Hills, California or its successor.

SIXTH: I hereby nominate and appoint Greg Garrison, [REDACTED], Los Angeles (Belair), California, as Executor of my Estate and if he is unwilling or unable to so act, then I appoint Sandro Tasca, [REDACTED], [REDACTED], Los Angeles (Hollywood), California 90046 as Executor of my Estate.

I authorize my Executor to sell, lease or mortgage the whole or any part of my Estate at either public

or private sale, with or without notice, but subject to such confirmation as may be provided by law. My Executor may, at his option, and in his absolute discretion, retain any securities, properties or other investments and continue to hold, manage and operate any property, business or enterprise that I may own in whole or in part at the time of my death, with or without order of court, the profits or losses therefrom, if any, to inure to or be chargeable against my Estate and not my Executor.

I authorize my Executor to file a joint income tax return for my wife and myself and to pay all or any portion of her taxes due thereon. If any additional assessment shall be made on account of any joint income tax return which my wife and I have filed, I authorize my Executor to pay such additional assessment without collection of any portion from her. The exercise of authority hereunder by my Executor shall be conclusive and binding on all persons.

EIGHT: I direct that all estate and inheritance taxes occasioned or payable by reason of my death, whether attributable to properties subject to probate, administration or to outside transfers, shall be paid out of the residue of my Estate disposed of by this Will as an expense of administration and without apportionment, deduction of reimbursement therefor, and without adjustment among the residuary beneficiaries.

NINTH: Except as otherwise provided in this Will, I have intentionally and with full knowledge omitted to provide for my heirs. If any person obtains a determination that he is one of my heirs-at-law, and if by reason of such status he would otherwise share in my Estate or any portion thereof, then I give the sum of ONE DOLLAR (\$1.00) and no more to such person. If any beneficiary under this Will in any

manner directly or indirectly contests or attacks this Will or any of its provisions, including paragraph B of Article FOURTH hereof giving the entire house to Olga Palinkas, any share or interest in my Estate given to such beneficiary under this Will is revoked and shall be disposed of in the same manner provided herein as if such beneficiary had predeceased me leaving no living lawful descendants.

TENTH: The words "child", "children" and "issue" shall include adopted persons, and the term "issue" shall refer to lineal descendants of all degrees.

ELEVENTH: As used in this Will, the masculine, feminine or neuter gender, and the singular or plural, shall each be deemed to include the others whenever the context so indicates.

TWELFTH: No interest shall be paid on any gift, legacy, or right to income under this Will or any Codicil thereto.

THIRTEENTH: If any provision of this Will is unenforceable, the remaining provisions shall nevertheless be carried into effect.
